## Blood Drive

Until the mid 1900s, blood was transfused exactly as it was drawn -- in its **"whole"** state. Often people would be on a donor list at the local hospital **and** called in to donate if someone needed blood. With the advancement of technology **and the** need to have a safe blood supply, changes came about in the blood donation process. Medical advances and modern surgical techniques have increased the need for blood. Because blood can be separated into components, **several patients may benefit from one** blood donation.

United Blood Services of Fargo, a non-profit community blood center, provides blood and blood components for patients in the area medical facilities. They conduct blood drives throughout the area.

Since 1988 the United Free Lutheran Church has sponsored the Greenbush Blood Drives which are held twice a year. The community of Greenbush has been very willing to participate in the drives, and its donations are greatly appreciated.

## Greenbush City Council 1905-2005

### *Creation*

The Village of Greenbush was organized January 6, 1905, under Chapter 145, Laws of 1885. This law, enacted by the Minnesota State Legislature, provided for the incorporation of villages and **defined** their duties and powers, and granted the council authority to execute ordinances as **necessary** to protect the peace, benefit, good order, regulation, convenience and **cleanliness** of the city, and **the health and well being** of its inhabitants. A total of 79 ordinances, some with amendments, have been **adopted to date**. **These ordinances give the council exclusive power to regulate merchants** and retailers, theaters, exhibitions, gaming, liquors, **manufacturing** and related activities.

Up until the year 1969, the **village operated under the standard** plan form of organization and had the **common weak mayor-council** form of government consisting of an elected mayor, an elected clerk who served as a voting member of the council, and three council members. **The** treasurer was also elected, but not a voting member of the council.

Ordinance #1 adopted at the first official meeting January 23, 1905, provided and established guidelines defining and regulating meetings, duties, and business of the village council.

### *Changing The Form of Government*

In 1967, the Minnesota State Legislature required every city operating under the Standard Plan to assume the Plan A form of government by January 1, 1970, unless the voters rejected it. On November 7, 1967, voters approved that the city operate under the Plan A form of government, which provided for appointment of the **clerk-treasurer and justice** of the peace. Under this plan, the clerk is no longer a voting member of the council. The council has all the administrative and legislative authority and responsibility that councils in Standard Plan cities have. Plan A retains **the weak mayor-council** characteristics and provides for an appointed **clerk-treasurer**, a **mayor**, and **four council** members. The entire council is elected at large by voters of the city. The mayor is elected for a two-year term

and each council member is elected for a four-year term, two are elected every four years. The Greenbush City Council meets monthly and special meetings are held as needed.

Like most cities in Minnesota, Greenbush incorporated as a statutory city, is a fourth class city and operates under Chapter 412 of the Minnesota Statutes and a number of other statutes that apply to all cities.

**The** year 2005 City Council is Mayor Scott Waage and Council Members Lavern Emery, Jon Foss, Sandy McFarlane, and Malthe Williamson.

### *Functions and Services Provided*

Public safety was apparently one of the council's first concerns as within the first year, a fire department was established, the fire hall and jail facility constructed, and constables, justice of the peace health officer, and marshals were appointed.

Safe and sanitary water was also a priority as a water tower, tank and well were constructed in 1905. By 1929, this tower was dismantled and a **new** wooden tank erected. In 1955, this old wooden tank was such that an emergency repair job was necessary and beyond **economical** repair, thus a new 50,000 **gallon** capacity steel tank was erected. In 1967, a new water tower was erected. The old tank **was** dismantled in 1982. Water mains were extended in 1909, 1919, **1938, 1945, 1946,** 1949, 1952, 1957, 1959, 1960, 1967, 1970, 1973, 1980, 1987, **1993, 1994,** 1996, and 1999, plus **minor** extensions in years **not** noted. Water meters **were** installed in 1937, but abandoned by 1983. Wells were constructed in 1910, 1919, and 1945 due to the extreme need for additional water for village use and the anticipated need by the creamery in 1951, 1960, and 1963. By 1970, **the** water was fluorinated as required by law. In 2002, **245** residents voted yes and 133 voted no for constructing a **new water treatment** plant.

In 1905, the council granted permission for telephone poles to be installed along the streets. In 1909, Tri-State Telephone and Telegraph-Leo was granted permission to build, operate and maintain a toll line and telephone exchange in and through the village for a term of 25 years. Northwestern Telephone Company installed direct dial telephone service in 1972.

Bonds were issued in 1916 for the construction of an electric plant, **which** the **village** operated until 1923. A fifteen-year franchise was granted to **Interstate** Power Company providing for the construction, operation, and maintenance of the electric distribution system. A street lighting system and substation was added in 1919. Years later, the electric franchise was granted to Otter Tail Power Company.

A grant in 1967 from the Economic Development Administration, U.S. Department of Commerce assisted in the construction of sewer lines, stabilization ponds, and lift stations. Property was purchased from Paul Gehres in 1963 for the stabilization pond construction site. Sewer mains were extended in 1970, 1975, 1976, 1987, 1988, 1993, 1994, and 1998, with minor extension and **repairs** in other years. A **grant** under the 1993 Flood Disaster Assistance Program, to rehabilitate portions of the city's sewer system, was completed in 1996.

Property purchased for a dump ground in 1937 was closed by 1983. Solid waste was then hauled to Roseau County Landfill and later to Mar-kit Landfill. The "Pay Per Bag" waste disposal system

was implemented October 1, 1994, to reduce solid waste and encourage recycling; this program was terminated July 1, 2004. In 1994, the city contracted with KaMaR Recycling to establish and provide a recycling program.

Concrete sidewalks and crossings were constructed in 1905, 1911, 1915, 1919, 1964, 1969, 1989, 1993, 1995, 1997, with minor repairs and extensions in other years. curb and gutter and overlay projects were completed in 1952, 1953, 1958, 1961, 1971, 1973, 1984, 1988, 1994, 1996, 1999, 2000 and 2003, with minor repairs and improvements in other years.

*Community and Economic Development*

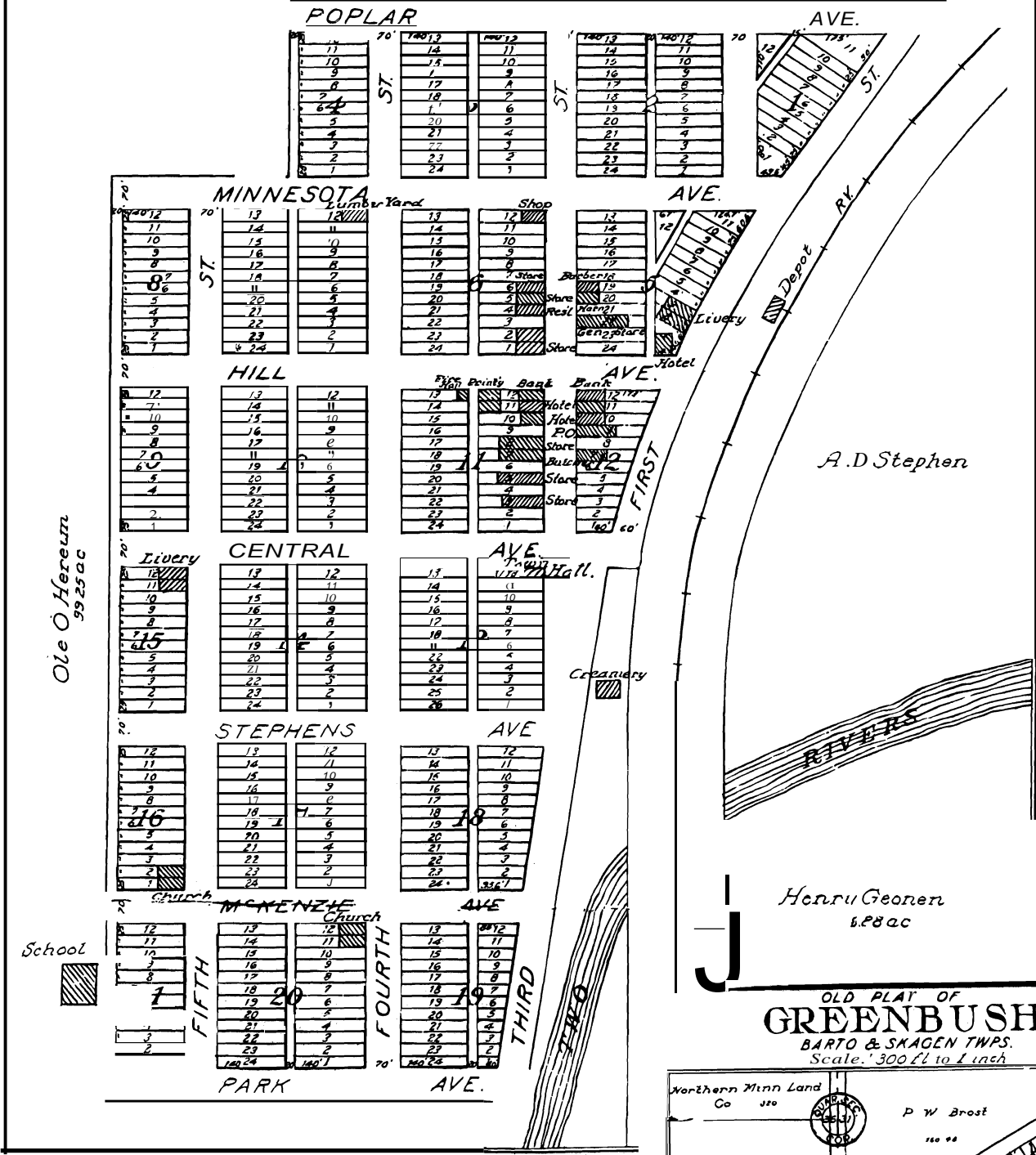
Throughout the century, the council has promoted community and economic development, along with beautification. City fathers have

developed parks and playgrounds, supported recreational programs and the construction of an outdoor pool, liquor store, library, airport, and related projects to improve the quality of life for area residents.

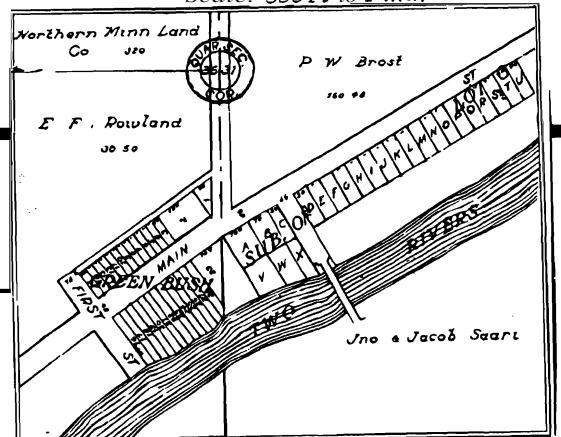

## City Council Minutes

Village organized January 6, 1905 under Chapter 145, Laws of 1885.

01/23/1905 - The first official meeting of the Greenbush Village Council was held 9:00 a.m. January 23, 1905, at the State Bank of Greenbush. Present were A.P. Kukowski, president; K.K. Grivi and John Engelbright, trustee; recorder T. Lundevall, T.G. Lanegraff, trustee, was absent. Ordinances #1 and #2 relating respectively to duties of village officers and intoxicating liquors were adopted.

01/30/1905 - The Greenbush Journal was designated as official paper of the village for the ensuing year, compensation of \$50 for year publishing all the proceedings once a month and 75¢ per folio for publishing ordinances. Adopted Ordinances #3 through #8. President to appoint a committee of two to make arrangements for lots for fire department and village jail, to report at next meeting.

02/07/1905 - Ordinance #9 through #14 were adopted. Village bonds were fixed as follows: recorder \$500; treasurer \$5,000; justice of the peace \$500; auctioneer \$500. The saloon license for the ensuing year was fixed in the amount of \$500. William Reilly and Peter Rindero were appointed constables. Dr. F. Young was appointed justice of the peace and Dr. Hubbard health officer. The president appointed trustees K.K. Grivi and John Englebright, to confer with the supervisors of Hereim Township and the County Commissioners in regards to building a bridge across Two Rivers within village limits.

02/15/1905 - James Duckworth was appointed marshal at a salary of \$40 per month. The marshal to be on duty from 12 noon until 12 midnight and to begin service on Monday February 20, 1905. The marshal was also appointed to serve as village fire warden without extra compensation.

02/18/1905 - Ole E. Oie was paid \$3 for recording Articles of Incorporation. The petition for donation of \$500 to Farmers Co-operative Creamery of Greenbush was granted on the condition that if said creamery at any time ceases to be a cooperative, the Village of Greenbush is to have a lien in said creamery for \$500.

02/21/1905 - Ordinance #15 relating to draying was adopted. The recorder's compensation was fixed in the amount of \$5 per month.

03/02/1905 - The bill of G.M. Gibbins for

\$200 for services rendered in regard to incorporation of the village was allowed in the amount of \$100.

03/04/1905 - Bond of Charley Nelson for liquor license with Mike Johnson and William Nelson was granted.

03/07/1905 - The bid from W. D. Lovell for construction of tank and tower, gasoline engine, etc. in the amount of \$3,749 was approved.

03/11/1905 - Trustees John K. Engelbright, K.K. Grivi and T.G. Lanegraff were appointed Board of Auditors.

03/13/1905 - 40 feet of the east end of Lots 13 through 17, Block 11, except 15 feet of the south side of Lot 17, which is reserved for alley, was bought by the village for city property in the amount of \$250.

03/21/1905 - The bridge committee recommended building a bridge across the Two Rivers at the foot of Park Avenue East & West.

03/22/1905 - The bill of G.M. Gibbins for \$200 was allowed in the amount of \$25, in addition to order #8 for \$100 (legal fee balance due for village incorporation). Entered into a contract with Sedlocek & Gerney for drilling a city well for compensation in the amount of \$300 depth down to 100 feet. For any depth below 100 feet at a rate of \$3 per foot to 50 additional feet.

04/04/1905 - Petition from supervisors from Town of Barto for donation of \$200 for roads was tabled to inquire as to where they plan to expend said amount if allowed. Ordinance #16 was adopted. Note: of all ordinances adopted, this is one of two missing from the official ordinance book.

04/06/1905 - Bid of Haugen Bros. for building the bridge across Two Rivers for \$944 including material, was accepted; to be finished in five weeks from date.

04/27/1905 - Motion to order W.D. Lavell to make a pit at the waterworks not to exceed \$80 and also gave him permission to build a small house for heating the pipe without any extra charge to the city.

05/11/1905 - The petition of R. McMahn for erecting telephone poles in the streets for local phone exchange was granted.

06/02/1905 - The resignation of John E. Thornten as trustee was accepted. John E. Thomten was appointed village marshal and was to take care of city waterworks for \$50 per month.

06/06/1905 - L.E. Frost appointed trustee. John E. Thompson was appointed street commissioner at a salary of \$1 per day. Herman Halgrims was hired to clean city well for \$35.

07/20/1905 - The petition for donation of village funds in the sum of \$80 for the benefit of the Greenbush baseball team was granted.

08/08/1905 - Trustees Grivi and Frost were appointed to erect a jail for the village.

09/14/1905 - Petition of property owners of Block 6, to have sidewalks built on all vacant lots of said block facing 3rd Street was granted. Ordinance #18 approved and adopted. This ordinance is missing from: ordinance book. M.J. Hegland was appointed village attorney at a salary of \$75 a year from date of meeting.

10/31/1905 - Lavoy Liller was granted a liquor licence and bond approved in the amount of \$2,000 with George Burkel and Nilo A. Boe as sureties.

11/07/1905 - John E. Thornten was appointed constable to fill vacancy of Harold Sanders, resigned. Dr. Jelstrup was appointed member of Board of Health to fill vacancy of Dr. I.G. Hubbard, removed.

12/05/1905 - K.O Dock was appointed justice of the peace to fill vacancy of Dr. Young, removed.

02/06/1906 - Resignation of John E. Thomten as village marshal and constable accepted effective February 07, 1906; W.V. Vreed was appointed at a salary of \$38.

02/17/1906 - The question of establishing a separate election and assessment district for the Village of Greenbush to be submitted to a vote of the people at the next annual election to be held the second Tuesday in March.

03/06/1906 - The statements of the village treasurer and recorder were duly examined, audited and approved. Treasurer's statement approved for publication.

04/03/1906 - Application of H. Sneve, Mike Johnson and John Engelbright were considered for office of village marshal; H. Sneve was elected village marshal and street commissioner on condition that he look after village waterworks at a salary of \$50 per month. Ole O. Hereim, Jr. appointed village assessor. Dr. Jelstrup, Torjus Lundevall and A.A. Burkee were appointed to the village Board of Health. Salary of village clerk was fixed at \$75 per year, said sum to include rent of council meeting room; law office of M. J. Hegland was designated meeting room. Council to meet first Tuesday of each month at 8 p.m. Greenbush Journal designated official paper, to receive \$25 annual for publishing council proceedings and legal notes for all other legal publications of the council. Committees appointed: M.J. Hegland and K.K. Grivi on roads, streets & sidewalks; Olaf Hildahl & G.N. Tillman on

contracts, insurance & poor fund.

05/01/1906 - Poll tax fixed at \$3, or in lieu thereof days labor. License fees: pool table \$5; Bowling alley \$7.50; auctioneer \$2.50 per day; dog tax & license male \$1; female \$2. Village marshal was made fire warden and salary raised to \$60 per month.

05/11/1906 - Village marshal was instructed to notify all saloons to observe the ordinance in regard to the 11:00 p.m. and Sunday closing, and keeping curtains down when closed. Village marshal was instructed to ring the curfew bell at 9:00 p.m. and see that it was observed.

06/08/1906 - Bids for road grade north of village opened and rejected. Grade work to be made by hire, Olaf Hildahl and A.P. Kukowski appointed superintendents of the work.

07/06/1906 - A land tax of 50 cents on every \$100 worth of real estate and personal property was levied. T. Lundevell and K.K. Grivi appointed as committee to make contract for grading road to village in Town of Soler.

08/06/1906 - M.J. Hegland was instructed to see Hereim Town Board in regard to expenses of road north of town, and get a settlement in regard to the money raised with the bonds before the dissolution (division) of the village and township.

09/04/1906 - Request for contributions to build bridge south of Old Greenbush by Town of Skagen refused.

10/02/1906 - K. Sneve was appointed marshal to April 6, 1907, at \$40 per month. Clerk was instructed to secure a joint meeting of the village council and supervisors of Town of Hereim.

10/08/1906 - Joint meeting with the Hereim Board of Supervisors. An agreement made by council and Hereim Town Board whereby Village of Greenbush was to accept \$301.41 as its share of the money raised by bonds before village and township were dissolved (divided) and the village agreed to construct a road south along the railroad. Carl Hereim was hired as the contractor, under supervision of council, and to receive \$4 a day for each man and team furnished, the council reserving the right to also furnish men or teams.

11/08/1906 - Approved to have work done on the road north from village, village marshal to supervise the work.

02/04/1907 - Meeting called for purpose of taking action in regard to the engine house and engine destroyed by fire. It was approved to purchase an engine for \$500. Marshal H. Sneve was authorized to hire

men to remove timbers and engine, and build a temporary enclosure for engine.

02/16/1907 - Liquor license for Fred Lavoy and Slominski & Bazal was approved. Liquor license of c.F. Heise was tabled until February 19, 1907. Clerk authorized to appoint two judges for March 12, 1907, annual village election.

02/19/1907 - C.F. Heise liquor license granted. Question limiting the number of saloons considered. Tabled until February 22, 1907.

02/22/1907 - Liquor license bond of Frank Lekon approved. Motion made and carried to limit the number of saloon licenses to be granted to four.

03/16/1907 - Liquor license application of Andrew Larson for unexpired term of Frank Lekon approved.

04/02/1907 - Bonds of M.J. Hegland, A.A. Burkee, K.O. Dock and William Reilly as clerk, treasurer, justice and constable, respectively, approved. Meetings designated 8:00 p.m. first Tuesday of each month at M.J. Hegland's Law Office. Clerk's salary was fixed at \$75, which included rent for council room. Treasurer's salary was fixed at 2% of all money received into treasury. Ole O. Hereim, Jr. was elected vice president of council. H. Sneve was appointed marshal, street commissioner and fire warden and to receive \$45 a month, and \$1 a day for each day of road or street work as commissioner. Christian Jelstrup, A.A. Burkee and & TOJus Lundevall appointed Board of Health members and to receive \$10 per year. M.J. Hegland elected village attorney at a salary of \$10 per month. President Kukowski appointed the following committees: streets, alleys, sidewalks & crossings, William Nelson and Ole O. Hereim, Jr.; police, purchase & license, M.J. Hegland and Ole Boston. Licenses were fixed as follows: Liquor \$500 annually; pool table \$15 each; bowling alley \$7.50 each; auctioneers \$5 per day; shows \$5 per day; peddlers \$5 per day; dog license \$2 for female, \$1 male; poll tax \$3 or 2 days labor for each person.

06/17/1907 - Approved resignation of H. Sneve as marshal, street commissioner & fire warden. Approved to dispense office of marshal. Ole J. **Batron** was hired to look after waterworks at \$8 per month.

07/02/1907 - H. Sneve appointed village marshal salary of \$25 per month and fee of 50 cents for each dog killed for non-payment of license fee and 50 cents for collecting dog license fee. Village marshal to look after the waterworks.

07/04/1907 - Liquor license application &

bond for Peter Rutkowski approved.

07/17/1907 - Ole J. Bottem and William Nelson were appointed to make plans and specifications for a building for the water apparatus and report at next meeting

07/25/1907 - Ole J. Bottem resigned as council member. Approved \$350 for road work on road running east of village. Carl Hereim appointed street commissioner to fill vacancy.

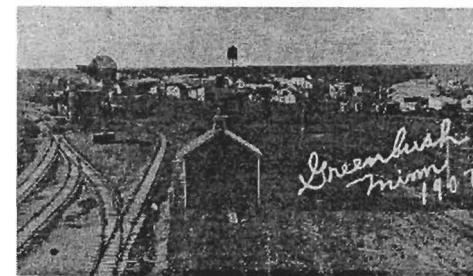
08/06/1907 - Liquor license & bond approved for Hans Rasmusson for one year.

08/16/1907 - Transfer of liquor license approved for Frank Schulte and Matt Barto from Fred Lavoy and D.F. Heiser.

08/19/1907 - Approved new engine house for waterworks be constructed as per plans and specification furnished by H. Sneve, architect, at a cost of \$497 and that the contract for the building before mentioned be let to H. Sneve.

10/01/1907 - Grivi & Kukowski were elected as a committee to have full power to contract for repair of water tank.

10/14/1907 - Clerk was authorized to issue a duplicate village warrant to N.S. 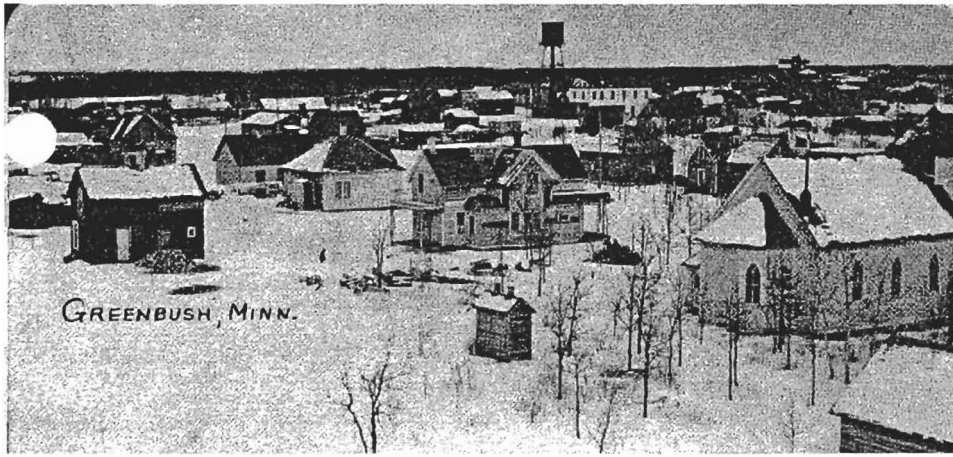

 07/01/1933 - All parties with off and on-sale running beer parlors were called over to the meeting and council granted that beer parlors may be open until 2:00 a.m. July 5th and from 11:00 p.m. until 12:00 midnight for both on and off-sale, effective July 1, 1933.  
 08/01/1933 - A.W. Clay, mayor, resigned; Joe Evans appointed mayor until next meeting.  
 08/10/1933 - Joe Rinowski, constable, resigned. Joe Rinowski appointed mayor.  
 10/04/1933 - Chas Nelson malt liquor license revoked.  
 01/02/1934 - Annual meeting. Taxes levied: running expenses \$1,800, bond interest \$1,400, poor fund \$300.  
 02/15/1934 - Olaf Lillegaard, Peter Spangrud and A. Lubinski asked and granted that they may hire the hall at a reasonable price providing may put on public dances and also that the beer parlors be permitted to keep open until 1:00 a.m. when dances are put on.  
 03/13/1934 - Petition by beer parlors of Olaf Lillegaard, A. Lubinski, Peter Spangrud and S.A. Mattson asking for permission to keep beer parlors open 1:00 p.m.-8:00 p.m. Sundays considered. Separate water fund established.  
 04/03/1934 - S.A. Mattson granted on-sale license together with his off-sale, to sell nonintoxicating malt liquor per verbal application and village ordinance; all beer parlors be granted both on and off-sale. On-sale license fee increased from \$50-\$70/yr.  
 08/07/1934 - Assessed value: real estate \$43,561, personal property \$15,036 moneys and credits \$16,778.  
 08/10/1934 - Outstanding bonds: August 1, 1922, electric light and water \$7,000, 6%, matures August 1, 1937; August 1, 1922, re-funding \$9,000, 6%, matures August 1, 1937; March 1, 1916 electric lights \$4,000, 6%, matures March 1, 1936; outstanding warrants \$9,431; Funds on hand: hall \$268.29, water \$9.95, poor fund \$909.94. Refunded these bonds, \$20,000 total at 4.5%, payable to First National Bank, St. Paul, MN.  
 09/24/1934 - Bennie Vigen granted malt liquor license. Andrew Lubinski license transferred to Cecil Barto.  
 01/05/1935 - Annual meeting. Bonds and oaths of officers elected examined/approved.

Taxes levied: running expenses \$1,800, bond interest \$1,400, poor fund \$100. First National Bank, Roseau, designated official depositories. Treasurer or bondsmen not to be held responsible for any funds that might be lost in case the bank be ordered closed.  
 02/05/1935 - Paid Olaf Hildahl \$39, coffin for a resident.  
 02/15/1935 - O.K. Christianson, Trustee of Village High Line Trust Fund appointed May 4, 1927, distributed a report, starting "on the 20th day of August 1923, the Peoples State Bank of Greenbush was appointed trustee of these funds with A.K. Czynson as cashier of the bank. This bank was ordered closed in the spring of 1927 and the funds lost in this bank was \$2,289.72, including interest, up to the time the bank was closed. When I became trustee, I consulted so the village would not lose any more, because we lost faith in the banks at that time, and I was instructed to invest the money in our own village orders until further arrangements are made and I am now holding village orders as follows: village orders bought up starting from 1927 \$4,410.51; discount \$3.58, bond interest paid to February 15, 1935, \$9,600; balance on hand Citizens State Bank, Roseau as of February 15, 1935 \$397.14; total to balance \$14,404.07." Receipts from Interstate Power Co., from August 8, 1927 - February 15, 1935, \$14,404.07.  
 03/05/1935 - Clerk instructed to contact Roseau relief committee to send labor to put roof on powerhouse and repair hall. Ole J. Pederson, project foreman.  
 04/02/1935 - On and off-sale licenses issued Olaf Lillegaard, Cecil Barto and Bennie Vigen March 31, 1935 through March 31, 1936. Fees: on-sale \$70, off-sale \$5.  
 06/04/1935 - Rev. Peterson to write the Ebenezer Home to try and get Lars Fiske placed in that home on the terms that Fiske's property be signed over to the village the village would pay the Ebenezer Home \$10 per month for his care.  
 09/04/1935 - Since a bank is now established here, designated State Bank of Greenbush as official depository, in addition to First National and Citizens State Bank of Roseau. Hall rent for Saturday shows \$2.50, Sunday shows \$3.50. John Aas, waterworks & Marshal, \$5 per month salary increase to \$35 per month, as demanded by Mr. Aas.  
 10/01/1935 - Elections for village officers shall be held and conducted under the so-called Australian Ballot System. Anyone desiring to become a candidate for office files an application at least ten days before

such election, with \$1 filing fee. Due to complaint of William Paulson, hall rent for shows adjusted, \$5.25 for two weekend shows on Saturdays and Sundays, and \$1.75 for weekly shows.

04/07/1936 - H.A. Haugen, creamery butter maker, submitted a \$167.37 bill for water line repair which had frozen. Council denied payment due to the fact that the creamery had entered into a contract to drill a well and after considerable time spent, had no success in getting water. Creamery officials, after consulting with village officials, connected to the village water main in the street in front of Hildahl's store, with the understanding that the creamery furnish all labor and material leading into the creamery and no obligation, whatsoever, assumed by the village for whatever might happen at any time between the regular main and the creamery. The village council is confronted with a problem in that they are unable to furnish the creamery with the supply of water required. The creamery, to be notified to make arrangements to furnish their own water in the near future or as soon as possible. Cecil Barto, Olaf Lillegaard and Bennie Vigen granted on and off-sale beer licenses,

05/05/1936 - New dumping ground matter to be investigated. No one allowed to connect to village water main until consulted with officials, apply with rules to protect from frost.

OS/25/1936 - Hereinafter anyone desiring connection to city water will have to stand all labor and material expenses.

06/02/1936 - Reimbursed firemen's department fund \$180 from water fund, transferred on May 31, 1935 due to no funds available.

07/07/1936 - Cecil Barto beer license transferred from Lot 4, Block 6 to Lot 6, Block 6. Lawrence Bizek granted on and off-sale beer license, \$75. \$500 transferred from poor fund to water fund.

08/04/1936 - A.W. Clay, President, resigned; Arnold Hildahl appointed. O.K. Christianson asked to be released as Highline Fund Trustee; N.D. Folland appointed.

09/01/1936 - Complaint received August 4, 1936, signed by beer parlor owners Bennie Vigen, Olaf Lillegaard, Cecil Barto and Lawrence Bizek, that notice had been served on them not to hand out or sell any beer on Sundays whatsoever, while at the same time a complaint was made on the Mayor for selling any amount of it; asked that the ordinance be amended so the beer parlors be permitted to sell beer in all licensed places

on Sundays after 1:00 p.m. until closing time. Council allowed them to be open on Sundays but not sell any beer.

09/09/1936 - B.F. Lane paint and repair water tank and build new frost box \$580.

10/06/1936 - Room in front of jail to be fixed up for clerk's office and council room.

12/01/1936 - Complete leader line outfit consisting of two inch hose and equipment for fire department \$165.47.

01/18/1937 - Greenbush State Bank designated depository. Complaint regarding sewage disposal from the Charles Hotel in street in front of Luterenan Free Church; proprietor of hotel notified in person by board of health to have this stopped.

02/02/1937 - Chas A. Anderson treasurer, resigned; E.R. Umpleby appointed effective March 1, 1937. A.E. Hildahl and N.O. Folland to audit books before they are turned over to newly appointed treasurer. L.J. Lorbiecki and H.J. Gavick appointed to investigate and look after the water supply in the village well. Olaf Lillegaard, Cecil Barto, Bennie Vigen and Lawrence Bizek granted beer licenses, on-sale \$70, off-sale \$5. E.R. Umpleby, treasurer, \$3,000 bond. Clerk to notify all Block 12 businessmen to have backyards along railroad cleaned up as soon as a suitable dumping ground can be provided for. Bill from Dr. G.A. Knutson for operation and professional service to Paul Mattson for \$124 allowed at \$100.

04/12/1937 - Property purchased for new dumping ground, triangular piece on the ridge road between road leading north to Town of Barto and old highway by Ed Housker consisting of about seven acres, \$150. Residents and businesses notified of this new dumping ground, to discontinue dumping on old ground by cemetery, to clean up their premises; special notice to everyone on Block 12 to clean back yards along railroad right-of-way.

05/04/1937 - Water meters to be installed. Cost estimate of meters \$11.82 each plus cost of installation charged against patron, deposit required. H.J. Gavick and L.J. Lorbiecki appointed to make investigation on installation of meters and rate of water rent per 1,000 gallons. Pinball machine license \$2 per month. Ingvald Lillemon, Harry Gilebo and Garfield Halvorson granted license to haul rubbish to dumping ground and that anyone who has rubbish, to contact anyone of these individuals. Roy M. Clark, beer license application Lot 20, Block 6, rejected. Herb Reese awarded job to put in culvert across road in front of his place to drain water from ditch into river and

to grade up road and part of other streets \$35.

06/01/1937 - Purchased 25 water meters.

08/09/1937 - Clerk to consult Interstate Power Co. regarding the location of the new substation.

11/22/1937 - To provide funds to meet interest and obligation of bonds, it was found necessary to change tax levy approved January 5, 1937 and amended as follows: general corporation purposes \$1,800, poor fund \$100, bond interest \$3,000, total levy \$4,900.

12/20/1937 - Financial problem due to insufficient funds, \$300 transferred from poor fund to hall fund.

01/14/1938 - A.E. Hildahl and N.O. Folland accepted as advisory members. All separate or special funds closed and canceled and transferred into one fund called the General Fund. All outstanding orders to be called by the treasurer for payment. To borrow from trust in denominations of \$1,000 as much as necessary to release orders. Interstate Power Co. \$900 check dated February 01, 1938, be deposited in Trust Fund at Greenbush State Bank. N.O. Folland appointed Trust Fund Trustee of Interstate Power Co. as Christianson released as trustee and that he be absolved from any personal responsibility.

02/01/1938 - Interstate Power Company franchise granted July 18, 1923, provided for the construction, operation and maintenance of a substation constructed in 1923 on property owned by the Greenbush Hospital, who has demanded it be removed, was granted permission to construct, maintain, and operate a platform type substation to be located on the company's transmission line along and on Poplar Street, west side of alley between Third and Fourth Streets, extending westward maximum of 20 feet.

03/01/1938 - Casper Snare to install water meters and charge \$10 each and \$1.50 for installation.

04/05/1938 - 20 more water meters ordered. Letter from Adolph Moen, Post #88 American Legion, requested to instruct officer of the law to strictly enforce the law regarding the sale of cigarettes, beer or any intoxicating liquors to minors and school children and they not be permitted to loiter in beer parlors or pool hall, play cards or pool; Also, shaking dice for treats forbidden in all public places.

04/08/1938 - Cancelled First National Bank & Trust Company, Minneapolis, MN, as paying agent for electric light bonds dated August 01, 1923 and forwarded to

Greenbush State Bank. Water works and electric light plant bond #5 due August 01, 1937, charged against Electric Highline Bond Trust Fund for \$1,000 and proceeds distribute as follows: Greenbush State Bank, cost to them \$914.50 and interest \$41.67 from August 27, 1937; E.R. Umpleby, surer, for general fund \$43.83. This bond now belongs to village Electric Light Trust Fund.

04/13/1938 - Chas A. Liddell, presented bonds numbered six and seven of the water works and electric light plant for payment of \$1,000 each, accepted in lieu or cash, to extend the principal for a period of five years at 4% interest.

05/03/1938 - A. Lubinski permitted to put in an underground cable for his telephone. Street committee to have parking places marked off on Main Street.

07/29/1938 - Karlstad State Bank entered into an agreement with the owner of the eight \$500 600 village refunding bonds of March 1, 1926, whereby the \$4,000 par value bonds together with interest accrued from March 1, 1936, for \$3,000 flat; village took advantage of this reduction offer and agreed to refinance this proposition for \$3,000 flat at 6% interest, \$1,000 payable annually.

08/04/1938 - Furnished two-inch galvanized pipes from water main by Lund's corner over to Swanstrom's, about 260 feet at 26 cents per foot, for Henry Nubson, new Free Church parsonage and Swanstrom to connect up to water main. They are to pay for all other expenses. John Aas to collect balance due on all water meters and when such patrons vacate premises they are to be re-\$10 for the meter. Any patron that refuses to pay \$11.50 for meter and installation, marshal to disconnect water service.

08/27/1938 - Greenbush State Bank purchased the \$7,000 outstanding village Water Works and Electric Light Plant Bonds of 1922, \$1,000 each, numbered one to seven, inclusive.

09/28/1938 - Greenbush State Bank entered into an agreement with village to carry the \$8,000 (eight \$1,000 at 6%) refunding bonds, numbered two through nine inclusive, dated May 1, 1922, and due May 1, 1937. Separate funds have been carried on by the village up to 1938 as follows: general, poor, water, hall and electric high line. The village entered into an agreement with Greenbush State Bank to refinance financial affairs and consolidate all funds into the General Fund.

04/04/1939 - A.E. Hildahl, trustee, resigned; Joseph J. Rinowski appointed. Notice to be

placed in the Greenbush Tribune to have all premises cleaned up and anybody that hauls debris to the dumping ground to obtain a permit first. Reimbursed Grant Hauger, Chairman of the Commercial Club and Christmas Committee, \$18.30 for supplies and expenses.

05/05/1939 - Chas W. Lindell appointed justice of peace.

06/05/1939 - Ladies aid hall rent \$2 per meeting during summer.

07/11/1939 - Paid Einar Johnson \$11 for exchange of space on Lots 11 and 12, Block 13. Recommended that compensation insurance be carried on members of the fire department, to be considered by the department at their next meeting. J.M. Roche attended meeting in Roseau with village and township officials establishing charges that need doctor's care: 50% of the Red River Valley Medical Society fee schedule adopted as the maximum allowed in relief cases; except confinement cases \$25 maximum fee. Maximum operating table and anesthetic fee \$7.50; mileage: 50 cents per mile for the first ten miles and 25 cents for additional miles; x-ray examinations \$5, hospitalization maximum fee \$2.50 per day.

07/22/1939 - Amended original agreement dated August 20, 1923, with Interstate Power Company, Dubuque, Iowa, covering the electric distributing system, street lighting system and sub-station, payments to be made to village directly, not Greenbush State Bank, who was trustee.

07/28/1939 - L.J. Lorbiecki appointed guardian for Jim Botoshe and H.J. Gavick for Charley Saice, as advised by the county welfare board, to guard monthly allotment and old age assistance checks to the best advantage and things necessary for living.

10/03/1939 - Taxes levied: general purposes \$3,000, bond interest \$1,500, poor fund \$100.

11/07/1939 - New election law requires polls open from 7:00 a.m. to 8:00 p.m., but could be changed by council resolution; council designated polls for election be open from 9:00 a.m. to 8:00 p.m. Election to be held December 5, 1939. Olaf Lillegaard to have ice house removed located back of his beer parlor in accordance to ordinance adopted October 10, 1938.

11/10/1939 - Permission granted to beer parlors to be open Armistice Day from 12:00 noon until regular closing time.

12/06/1939 - Letter presented by individuals located on Block 12 including C. Nelson, Bennie Vigen, E. Stauffenecker, Orin C. Nubson, Chas Nelson, H.M. Haug and An-

drew W. Clay, to open up street in rear of their respective property was tabled until the above parties present papers and legal advice from an attorney how to proceed. Permission granted to school to use the hall for basketball practice for \$1.50 each night, from afternoon to 6 p.m. Six more water meters ordered.

01/09/1940 - J.M. Roche, reelected president for two years and L.J. Lorbiecki, trustee, for three years; both qualified and oath of office taken.

02/06/1940 - Approved payment to Budd Hospital, Roseau, per case presented by Henry Johnson, whereby his wife had to have an emergency operation and he was not financially able to pay for it.

03/12/1940 - On account of so many additional reports and extra work added to the clerk's office, salary increased to \$20 per month effective January 1, 1940. Notices to be replaced, if destroyed, regarding no mixing of intoxicating drinks in beer parlors. Clerk instructed to investigate how to restrict certain areas for building purposes, so as to prevent getting a shanty town in a large portion of village. J.M. Roche and O.K. Christianson appointed to consult Mrs. Baltz, County Welfare Board, on arrangement for care of Mrs. Sunneson, who is in need of much care. Approved favoring villages and townships go back on the county system as all charity cases can be better handled and taken care of.

04/02/1940 - Workmen's Compensation Insurance to be purchased for fire department members, \$96.

04/29/1940 - Piano purchased for hall from H.M. Hitterdal, Thief River Falls, \$80.

07/02/1940 - Nick Pulczynski, Ingvald Lillemon, Chas Lindell and R.W. Hugg to police July 4th in addition to John Aas. Beer Parlors granted permission to be open until 2 a.m.

08/06/1940 - Taxes voted: running expenses \$3,100, bond interest \$1,500. Carnival granted permission to put on their performance in village streets.

09/04/1940 - Clerk to investigate and purchase Lot 4, Block 2, to put Chas Saice building on, and Lot 1, Block 2, by Emma Sunneson House, if not sold.

10/10/1940 - Because fire hall and water-works are connected to same building and not knowing what might take place in the future, it was agreed to rent certain room in the power house to the county for \$5 per month for a term of three years with the option of seven years, effective December 1, 1940. Maintenance and changes or remod-

eling to the building to be paid for by the county in return for one year free rent.

11/07/1940 - Interstate Power Co. requested franchise, to be investigated and obtain legal advice. Mrs. Strom to stay with Emma Sunneson, to be paid \$10 per month from county old age assistance.

01/13/1941 - First meeting of the year, committees appointed, regulation of licenses, salaries determined, etc.

03/04/1941 - Considered joining the League of Municipalities.

OS/29/1941 - Ben Vigen submitted application to request permission to keep beer parlor open Decoration Day, May 30th. The Commercial Club met January 23, 1941, and considered this day a legal holiday. The council decided that all business places be closed.

06/04/1941 - Olaf Lillegard, Ben Vigen, Lawrence Bizek and Cecil Barto, were granted permission to keep beer parlors open on the following holidays this year: July 4th, Labor, Annistice and Thanksgiving Day, on account of increase in license and different activities they are asked to donate to, as per request. The community band was granted permission to use the hall for practices for about three months, free of charge, on condition consult the hall manager and give a free concert in the village at least once every month.

07/01/1941 - Jim Botoshe to be put on relief stamp plan and an order of \$15 be issued to his guardian H.J. Gavick.

07/07/1941 - Ordinance #21 adopted granting Interstate Power Company, a franchise for a period of fifteen years, for the purpose of producing and furnishing electric energy for light, heat and power. Contracted with Interstate Power Company to provide nineteen-100 watt street lights, to bum from dusk to 1:00 a.m., service charge: 55 cents per lamp per month; energy charge: three cents per kwhr and electric energy for municipal pumping plant at 3.5 cents per kwhr. Interstate Power Company paid amount due under the agreement between village and Minnesota Electric Distributing Company, dated August 20, 1923, amendment dated July 22, 1939. Final payment \$4,500.

09/02/1941 - Due to complaint regarding a lot of shooting, it was determined that no one be allowed to carry any fireann unless a pennit is obtained from the village council. Chas Lindell, Justice of the Peace, resigned.

10/07/1941 - School granted pennission to rent hall for \$1.50 per practice; to also be used by school for parties. Clifford Heltne

appointed justice of the peace in and for the unexpired term of Chas Lindell. Lots 4, 5, and 6, Block 7, purchased for appraised value of \$8 per lot, prior to the county forfeiture land sale for nonpayment of taxes and \$15 paid to Mathilda Paulson, former owner, for quit claim deed to obtain a clear title. These lots to be used for parking and other purposes.

11/03/1941 - Ordinance #22 adopted licensing and regulating the retail sale of cigarettes and cigarette wrappers.

12/02/1941 - Oaths and bonds of elected officials examined and approved. H.J. Gavick and L.J. Lorbiecki appointed to investigate proposal to enlarge the hall.

02/03/1942 - Dog license fee \$3. Non-intoxicating malt liquor licenses granted to Olaf Lillegard, Lawrence Bizek, Cecil Barto and Bennie Vigen, \$95 on-sale license fee, \$5 off-sale license fee.

04/07/1942 - Ingvald Lillemon, Harry Gillebo and Herman Omdahl appointed to haul rubbish to dump ground. Anyone else must obtain permit from village or be subject to a fine.

06/09/1942 - Creamery water rent fee 20 cents per thousand gallons.

07/13/1942 - Due to sufficient funds, two more bonds, refunding bonds number seven and eight were paid.

08/04/1942 - Robert Evans appointed special police during August 6, 1942, carnival.

12/01/1942 - Olaf Lillegard beer license transferred to Joe Slominski.

01/05/1943 - Annual regular meeting. Clerk financial statement examined and approved. License fees, committees, salaries, etc. approved. Paid \$20 to School-Dist. 66 share donated for upkeep of skating rink. Complaint received and discussion regarding boys and girls of school age, and minors, frequently allowed in beer parlors and pool room, and taking part in different games of chance. Discussed that the state is getting more strict and that the school board and village together provide a skating rink for amusement. Siren sounds at 9:00 p.m. curfew and parents asked to assist in observing these rules. \$12 cigarette licenses granted to: Ben Vigen, Clay Drug Co., Curtis Nelson, L.J. Lorbiecki, Cecil Barto, Chas A. Anderson, Lawrence Bizek, Grant Hauger, Joe Simons, J.M. Roche, Geo Alley.

02/02/1943 - Instruction given by Roseau County Welfare Board that an allowance had been granted to the Harry Brazier family of \$60 per month, food/fuel, but that this allotment did not include Mr. Brazier and that the village had to provide a separated allot-

ment for his care; \$10 per month was granted. Operators of beer parlors and pool hall attended and promised to cooperate with the council regarding school age boys and girls violating rules and regulations i.e. entering their premises and taking part in games of chance.

03/02/1943 - H.J. Gavick trustee, died February 19, 1943; Ingvald H. Lillemon appointed. J.M. Roche appointed guardian for Jim Botoshe.

04/06/1943 - Beer licenses granted to Joe Slominski, Ben Vigen and Cecil Barto, \$100 fee. Reissued \$17,000 electric light bonds, now designated as refunding bonds of 1943, \$2,000 in 1944 to 1950, and \$3,000 in 1951, Kalman & Company, Inc., fiscal agent.

05/31/1943 - Sold house occupied by Chas Saice to Emil Schaller for \$70.

07/06/1943 - Taxes approved: \$2,750 running expenses, \$100 poor fund.

12/14/1943 - \$20 approved for Mrs. Emma Sunneson, per demand of Mrs. Nora Button, Hackensack, MN, whom is now bedridden and needs more care, receives \$40 per month from county welfare.

03/09/1944 - Beer on-sale license increased to \$145 per year.

04/11/1944 - Beer License granted to Bennie Vigen, Cecil Barto and M.H. Carpenter. Mr. Carpenter was ordered to appear before the council. He was ordered to conduct a decent place of business, according to the rules and regulation of the law.

05/02/1944 - Hall rent raised to \$2 per night for weeknight show, \$6 for Sunday shows, effective July 1st. Building permit granted to Paulson Bros. and the creamery. L.J. Lorbiecki appointed as village representative on the post war planning committee.

06/06/1944 - Clifford Heltne appointed justice of peace for two years or until the next annual election.

07/15/1944 - Lawrence Bizek beer and cigarette license granted.

08/02/1944 - J.J. Rinowski, trustee, resigned; Grant Hauger appointed. Commercial Club granted a permit for carnival show. Gilman Aas and Nick Pulczynski appointed police for the carnival. Since this was the last meeting attended by O.K. Christianson, clerk, Ingvald Lillemon was appointed as temporary hall manager.

08/04/1944 - O.K. Christianson resigned as clerk; Grant Hauger appointed as temporary clerk. Resolution adopted to agree to indemnify and save hannless the United States of America and the Land O'Lakes Creameries, Inc. from any and all claims, actions, suits, or demands arising or to arise from



the discharge and disposal of the sewage wastes from proposed construction and operation of a powdered milk plant.

08/05/1944 - Purchased O.K Christianson property and building, which housed the village records, for \$350.

09/05/1944 - Approved payment up to \$85 to Dr. Boreson, Thief River Falls, extractions and new set of false teeth for Clarice Johnson, as per letter of Dr. Boreson forwarded by the welfare board. Charlie Anderson appointed to take charge of books necessary to handle city water records efficiently. Notice to be published regarding ordinances against sling shots and curfew being enforced now that school is in session.

10/03/1944 - Chas Anderson \$5 per month salary increase for additional work in connection with city water books. Clerk salary \$10 per month.

11/20/1944 - Sunneson house rent \$10 per month.

12/05/1944 - General election day. Election results canvassed by the council and results were as follows: Herbert Reese, trustee three years; Chas Anderson, treasurer two years; C.W. American Legion granted permit to conduct a dance at hall, village to provide police protection, \$20 permit fee.

02/06/1945 - Street lights to be turned off at 12:00 midnight, dance nights at 2:00 a.m. Ingvald Lillemon appointed hall manager and C.W. Hershey as his assistant.

03/13/1945 - Business places shall comply with national curfew order, be closed and have lights out by 12:00 midnight. Approved S.G. Johnson's five acres be platted, located north of Poplar Avenue, but must provide right-of-way easements for street and alley. Bid of O.K Machine approved for drilling new 6" well, complete with casing, due to the extreme need for additional water for village use and anticipated need for creamery.

06/05/1945 - Beer license granted to Henry C. Widmark. Extra policemen hired for June 9th Sheep Days celebration.

07/03/1945 - Taxes voted: running expenses \$2,700, poor fund \$100. No beer sales permitted on July 4th.

07/09/1945 - Joint special meeting held with the Greenbush Association of Commerce 5:00 p.m. war standard time at the Great Northern depot. Resolution adopted that

Greenbush territory comply with war standard time.

08/07/1945 - General discussion held on location of a future airport.

10/02/1945 - Joseph Kaml granted beer and cigarette license. Agreed to sell Lots 4, 5, 6, Block 7 for \$300. Lot 21, Block 11 appraised at \$75. Approved village pay one-half cost to extend water main from Rev. Nystuen's house to the southwest corner of former Avon Harper house.

11/06/1945 - J.M. Roche, president, and C.W. Hershey, clerk, resigned effective November 7, 1945.

11/16/1945 - Ingvald Lillemon appointed president until December 4, 1945, village election. Claire Swanstrom appointed clerk.

12/04/1945 - Election held, Ingvald Folland, president two years; Lawrence Lorbiecki, trustee three years; Claire Swanstrom, clerk two years. Knute Grahn was paid balance of \$325.75 for drilling city well; approved that he purchase pump and necessary fitting to hook up to new well. General discussion held regarding advisability of having a local municipal liquor store.

01/02/1946 - General discussion regarding the possibility of enlarging the hall, the urgent need to repair water meters and extend water mains.

01/21/1946 - Due to the death of Mrs. Sunneson, house to be offered for sale for \$400 and Carl Throngard permitted first chance to purchase.

02/05/1946 - Harley Anderson and Charley G. Johnson granted permission to make allowance for across street, east and west between their properties when platted.

03/05/1946 - On and off-sale beer license granted to Henry Widmark, Lawrence Bizek, Joseph Kaml and Philip Stromlund, on-sale license fee \$145, off-sale \$5. Payment of \$15 for dues to the League of Minnesota Municipalities. Inquiry to be made to Ottertail Power Co., requesting special rate on electric ranges. Approved road construction east and west in front of school.

04/02/1946 - Mike Korczak cigarette license, on and off-sale license granted. Cigarette license also granted to Gust Heglie. Board of Health to handle the spring clean-up campaign.

04/30/1946 - Legal opinion to be obtained regarding proposed plan that the village, as owners of the airport, lease the airport property to the Greenbush Flying Service Air Club.

05/07/1946 - Business places to refrain from allowing customers to run up charge accounts to be paid by the village without first

receiving approval of the council. Ordinance #23 adopted regulating the construction of buildings in the Village of Greenbush.

05/17/1946 - Fees for building permits were set at \$1 for residential and \$2 for businesses. Water main extension from Fifth Street and Stephen Avenue north and west to Block 1 alley of Pulczynski Addition, thence south to end of Block 1. Hookup fee of \$25 per lot was established. Written application to be submitted to the Department of Aeronautics for approval of the site to be used as a Municipal Airport.

05/20/1946 - Pulczynski's Addition plat approved.

06/29/1946 - Two council representatives to meet with Otter Tail Power Co. officials regarding lower rates and additional street lighting. Powerhouse rental fee to Roseau County Highway Department \$12.50 per month. Greenbush Theatre hall rent \$3 per show night for Saturdays and Sundays. Quarterly water rates: \$7 minimum for businesses and \$3.50 residential.

07/03/1946 - North Addition plat approved.

07/30/1946 - Purchased airport site for \$1,600, \$10 license fee. All funds donated by Greenbush Airways, Inc.

08/06/1946 - In view of the increasing amount of rowdiness and disturbance of the peace in the village, the council ordered the marshal and justice of the peace that persons creating and entering these disturbances be arrested and fined. Resolution approved with the highway department permitting tree planting project at the "Y"; village responsible for care and maintenance of the trees. Sophie Pulczynski, Sophies' Eat Shop, granted cigarette license.

09/03/1946 - September 1946, new lower class "B" electric rates effective with Otter Tail Power Co.; additional street lights requested. Traffic control recommendations submitted by Vernon Fugleberg, on behalf of the Greenbush Commercial Club, were approved by the council.

10/04/1946 - Beer Parlors ordered to close promptly at 11:00 p.m.. Minors to be out of all business places and off the streets by 9:00 p.m. Cigarette and pool table licenses granted to Curtis Haugen. Request by Mr. Wayne Sanders, on behalf of the American Legion, to move the legion hall to the lots behind the village hall, granted.

11/05/1946 - Ten year agreement approved with Otter Tail Power Co. to furnish all night street lighting. Harley Anderson granted on-sale beer license. Approved \$200 to the Fire Department to purchase necessary equipment for new fire truck recently purchased.

12/12/1946 - Ordinance #14, licensing and regulation of billiard pool tables, and Ordinance #20, licensing and regulating the sale of nonintoxicating malt liquors, was read and explained to Henry C. Widmark, Philip Stromlund, Mike J. Korczak, Joseph Kaml, Harley Anderson, Curtis Haugen.

12/18/1946 - Approved to lease the Greenbush Municipal Airport to Greenbush Airways, Inc. at \$1 per year for ten years, in accordance per bid.

01/11/1947 - Alfred Fredricks did not qualify as justice of peace.

01/27/1947 - Village will assume financial responsibilities for the care of Dinus Johnson at the Albertson's Rest Honle, Frazee, MN, effective February 1, 1947; Olaf Hedlund to look after his property. Beer license issued to Harley Anderson on November 1, 1946, revoked for cause effective January 27, 1947. It is unlawful for clubs to sell intoxicating liquor, therefore, the village council does not sanction the sale of intoxicating liquor by clubs.

02/04/1947 - Fire department to make recommendations for limitations in the new fire zoning ordinance. Acknowledged receipt of \$1,921.75 from Greenbush Airways, Inc. as a donation for the Greenbush Municipal Airport.

02/11/1947 - Municipal engineer Winston C. Larson, Detroit Lakes, to make preliminary survey for proposed sewer system and treatment plant.

03/04/1947 - Nonintoxicating on and off-sale license granted to H.C. Widmark, Mike J. Korczak, J. Kaml and P. Stromlund. To sell village building 10'x12'. Acknowledged receipt of funds from Greenbush Airways, Inc. in the amount of \$477.50 as a donation to the airport.

04/01/1947 - Decided to terminate publication of proceedings in the Greenbush Tribune as too expensive; E.R. Umpleby would not publish them at a flat rate of \$1 per publication. Building permit granted to E. Stauffenecker for a locker plant in the fire zone limits, upon approval of fire chief.

05/07/1947 - Mayor I.S. Folland instructed to sign the BCF form 405, an agreement with the Federal Works Agency, Bureau of Community Facilities, to advance \$3,200 to plan preparation of proposed municipal sewage collection system and treatment plant. Arley Brandvold and Ben Vigen granted cigarette licenses. Ben Vigen granted on and off-sale beer license. Mayor to investigate Dinus Johnson relief case. Ordinance #24 adopted - new fire zone ordinance for blocks 5, 6, 11 and 12. Matter of garbage collection tabled

until report by clean-up committee at next meeting of the Commercial Club. R.W. Huggett, trustee, resigned; Vernon Fuglebergh appointed.

05/13/1947 - Approved form 110A for plan request to the Department of Aeronautics for Municipal Airport. Vernon Fugleberg appointed to investigate having the fire siren sounded at 12:00 noon, 6:00 p.m., and 9:00 p.m.

06/04/1947 - Mayor to notify Avon Harper to cease pumping septic tank directly on top of the ground. Health officer to be notified of any future complaints. Rented northwest portion of fire hall to Don Lindgren at \$10 per month.

07/01/1947 - Taxes voted for the year 1948: revenue 20 mills, road and bridge 15 mills, fire department 1 mill, water and light 5 mills, band 1 mill, park 2 mills, poor \$500. To hire extra police as needed.

07/18/1947 - E.O. Paulson manager, Greenbush Theatre, notified that it is not feasible for village to remodel projection booth to the standards prescribed in the order of the State Fire Marshal dated July 11, 1947. Village to furnish \$25 maximum poor aid to Mrs. Andrew Nesteby. Approved up to \$30 for an airport sign.

08/05/1947 - Acknowledged receipt of Lionel Hopkins \$120.50 donation for the airport.

10/07/1947 - Permit granted to operate bingo games at the school carnival November 21, 1947, and to St. Aloysius Church at a bazaar to be held November 21, 1947. Village hired two extra police for Halloween night, October 31, 1947. Cigarette license granted to Elling Erickson.

12/02/1947 - Agreed to pay \$50 to assist financing of supervision at the school skating rink Sundays and evenings. Ordinance #25 adopted to prohibit unloading or parking of trucks on Main Street (Third street) from south side of Highway 11 to Minnesota Avenue on the north, a distance of two blocks. Extra cop hired for one month to help enforce Ordinance #25 and do other police duties. The 36 votes cast at the election were canvassed with results as follows: Arthur Braun, mayor, two year term; Herbert Reese, councilman, three year term; Claire Swanstrom, clerk, two year term. Clerk instructed to contact Ben Lieberg and direct a more regular pickup of garbage. Acknowledged receipt of deed from Greenbush Airways, Inc. for the portion of land adjoining the airport, where hangers now stand; lease granted for this portion of property stipulating that they would have the right to move

hangers off land if desired.

12/09/1947 - Title acquired to Lot 19, Block 5, owned by Dinus Johnson; agreement signed that Mr. Johnson or his legal representative would have the option to buy back by reimbursing village the amount disbursed on behalf of Dinus Johnson, and agreed to pay him \$136.70 to pay off debt to give the village a clear title.

12/17/1947 - Approved the county rerouted Highway 5 to enter village from the west and connect with Highway 11 at the intersection Central Avenue and Main Street, for the purpose of controlling traffic.

01/06/1948 - Cigarette licenses granted to Sophies Eat Shop, Gust Williamson Grocery, Anderson's Grocery, Philip Stromlund Tavern, Bennie Vigen Tavern, Henry C. Widmark Tavern, Morty's Cafe, George Alley Store, Elling Erickson Store, Legion Post #88, Joe Kaml Tavern, Clay Drug Store, Guy W. Johnson Recreations Parlor, and Arley Brandvold Grocery. If Arnold Solom does not pay the fine imposed by the Village Justice Court, he is to serve the term in jail as per sentence.

02/03/1948 - To enforce no truck parking ordinance and continue to have an extra cop to enforce this ordinance and do other police duties, but to use discretion regarding farmers with trailers who stop for a few minutes load or unload produce in the zoned areas. License fees for 1948: \$5 off-sale, \$495 on-sale, increase earmarked to pay extra police costs. Sidewalks on Third Street to be repainted for stall parking.

04/06/1948 - Joe Kaml granted permission to build fence three feet out on the sidewalk in front of Lot 10 Block 11, while new building is under construction. Approved transfer of his beer license to new location.

05/04/1948 - Bid specifications and plans for the Greenbush Municipal Airport receive from the Department of Aeronautics and agreed to advertise this job on bids; village to pay \$2,500 for this project, \$7,500 to be paid by state. Up to \$200 in assistance granted to Sheep Day Committee to purchase 12 acres of land for Sheep Day activities, locate east across the railroad tracks and south of the river. Herbert Reese, resigned as trustee, due to the fact his work takes him away from home so much of the time; Maynard Peterson appointed.

06/01/1948 - Bid of \$10,933.55 received from Herbert Reese for construction of the municipal airport with a rider attached that if no additional top soil need be hauled in, the bid would be lowered in the amount of \$324.35. This bid was larger than the

\$10,000 allocated for this project, it could not be accepted this meeting. A telegraph request was forwarded to the Commissioner of Aeronautics, to have this airport project allotment increased to \$12,500. If approved, the village council was authorized by Mr. Hanson to accept bid submitted by Mr. Reese. Building permit of Peter J. Burkel to construct turkey sheds in the village rejected and he is to be notified to move or take down his sheds on or before July 1, 1948. To cut down on the dust problem, calcium chloride to be tried on streets in the business district to see how effective and expensive it would be to treat streets in this manner.

06/15/1948 - Department of Aeronautics approved airport project allocation in the amount of \$12,500. 25% or \$3,125 of total project costs funded by village, receipt acknowledged in amounts of \$2,050 and \$625 from Greenbush Airways, Inc.; 75% or \$9,375 funded by state. Bid of Herbert Reese approved for his project. Building permit granted to Stanley Grabanski, but advised to choose another site, more appropriate for the new dwelling.

08/03/1948 - Alley of proposed Solom Addition to be brushed so power company can install light poles. Granted permit to hold a bingo stand in the village on Hospital Day, September 25, 1948, proceeds to benefit the Greenbush Community Hospital.

09/07/1948 - Mrs. Nina Lund, Mrs. Anna Berntson, Mrs. Mable Gordon appointed judges of the primary election. These appointments were made by drawing names out of a hat. Louis LaVoy appointed special police, \$100 per month salary, effective September 15, 1948, continuing until terminated by village council.

10/05/1948 - Louis Lavoy suspended as special police officer until further notice because of complaints regarding the action and his execution of duties on Hospital Day. Clerk instructed to write to Ottertail Power Co. regarding the poor service and getting the street light project underway, and also to H.R. Chapin, Roseau County Highway Engineer, to investigate reason for the hold up on the road job half mile north and the S curve project.

11/03/1948 - Voting hours were set for 10:00 a.m. to 4:00 p.m. for all subsequent annual village elections. \$75 to be offered Ray Bialke for land and moving small buildings to open alley through North Addition. Guy W. Johnson to be contacted about job of regular cop.

12/14/1948 - Election results: L.J.

trustee; Chas A. Anderson, treasurer; Harley C. Trangsrud, justice of peace, Ben C. Bendickson and Clifford C. Helt tied for second place. Ottertail Power Company currently in town installing the additional street lights. Mayor directed to contact Otter Tail Power Company about installing street lights in the business alleys. Due to numerous complaints, letter to be sent to Herbert Reese regarding the speedy and reckless driving of his sons.

01/17/1949 - Solom's Addition plat as a part of the village of West Greenbush approved (owned by Mrs. Anna S. Solom).

02/01/1949 - Revised tax levy approved: general revenue \$1,500, road and bridge \$1,100, interest and principal; \$2,600, fire department 1 mill, water and lights \$700, band \$75, park \$150, poor \$700. Upon Elling Erickson's request for abatement of taxes, his estimated valuation of his merchandise was set at \$18,571. Clerk instructed to have the name of M.J. Kotchevar added to the list of persons to be assessed for personal property taxes and to have him reassessed for 1948 because his assessment sheet has been lost.

02/08/1949 - Met with tavern owners Joe Kaml, Ben Vigen, Philip Stromlund and Mike Korczak regarding the sale of liquor, sale of beer on Sunday, dirty and unsanitary toilets. Further infractions of the ordinance governing sale of beer would mean revocation of license.

03/01/1949 - Greenbush Airways requested to cancel their airport lease.

04/05/1949 - Pool table and cigarette license granted to Lloyd Paulson. Approved non-profit or charitable dances on Saturday evenings. Adopted ordinance licensing and regulating the operation of juke boxes.

05/03/1949 - Rent for Dinus Johnson house \$25 per month. Philip Stromlund on and off-sale non-intoxicating malt liquor license revoked effective May 4, 1949, reason: bootlegging. Approved to pay one-half cost of repairing and replacing old sidewalks in the commercial district. Larson & Swenson Plumbing & Heating to install water main along Third Street. Purchase land south of Highway 11 and north of Two Rivers from Robert E. Evans \$250; this land to be beautified for a roadside park.

06/07/1949 - \$100 approved for park project of tree on land purchased for roadside park. Six inch water main to be extended another block north along Third Street if the cost did not exceed \$3 per foot.

07/05/1949 - Nickelodeon license granted to Joe and Dorothy Kaml.

08/02/1949 - Final payment of \$9,076.16 for the construction of the airport approved. Due to complaints, Harry & Chucks Recreation to be contacted regarding their operation of pool tables on Sundays Peter Dembiczak granted cigarette license. Collins Bros. cigarette license \$6 and an on & off-sale non-intoxicating malt license \$500.

09/06/1949 - A.B. Larson hired as extra police until January 1, 1950, \$175 per month salary. Dorothy Kaml granted on & off-sale beer license. The fee was set at \$250 in view of the half interest she shared and paid in the licenses issued to Joe Kaml April, 1949, which were revoked for cause.

10/04/1949 - Proceedings to be instituted to vacate alley in Block 5. \$250 paid to Greenbush Community Hospital for "Greenbush Indian" bid at hospital sale by Mayor on behalf of village. Approved purchase of resuscitator for the Greenbush Community Hospital. Hall rent for auctions \$25 per day. Nickelodeon license granted to Mike Koiczak.

12/06/1949 - Election results: Art Braun, mayor; Bobby D. Wollin, clerk; Vernon Fugleberg, trustee. Reduced Farmers Cooperative Creamery Association real estate assessed valuation from \$4,250 to \$2,400 for year 1948. \$629.07 receipt acknowledged, refunded from the State of Minnesota Department of Aeronautics on the under run of the airport project. Funds for this project initially furnished by Greenbush Airways, Inc., therefore this said amount was refunded to them. Dinus Johnson requested to be placed in the Ball Clinic at Excelsior Springs, Missouri, and was tabled. Justice of peace instructed to add court cost for someone to stay up with prisoners held in jail awaiting trial. Due to complaints, Moenzimek Post 88 commander to be notified that the council does not approve dispensing liquor on Sundays. Autos and vehicles left standing on Main Street over 72 hours to be moved at owners expense. School to be notified that the village did not appropriate funds for a caretaker at the school skating rink.

01/03/1950 - Tax levy approved: general revenue \$2,000, road and bridge \$1,100, interest and principal \$2,200, fire department 1 mill, water and light \$700, band \$75, park \$150, poor \$1000. Hired A.B. Larson as marshal for a one year term at \$175 per month. Marshal instructed by mayor to make his beat every hour and make his whereabouts known at all times.

03/07/1950 - Determined that the assessor

assess real estate one-fifth of actual valuation, the same as last year's schedule.

3/29/1950 - Mike Korczak was denied a beer license for one year. Paul Pulczynski granted an on and off-sale beer license for one year.

04/04/1950 - Mayor Art Braun opposed granting a beer license to Paul Pulczynski, but it was unanimously approved by all other trustees. Mr. Pulczynski was issued license without the mayor's signature. Rent will remain the same at \$35 per month for the Dinus Johnson house.

05/03/1950 - Following Mrs. Phil Stromlund's appeal for lower rent on the Dinus Johnson house, the council approved the village pay cost of paint at the Gamble Store. Harley Trangsrud reported threats of violence by Herman Omdahl to certain residents. Agreement with Dinus Johnson regarding plans for his future care at the Greenbush Hospital was approved. John Delmaire granted permission to rent hall for roller skating one night per week on a 20% basis with a \$10 minimum fee each night.

06/06/1950 - Village to purchase and be responsible for the public address system recently delivered to the Mayor. Ben Lieberg's application for permit to build a bam was refused.

07/07/1950 - A reduction on the part of the D. Johnson bill regarding his physician's bills were approved for payment. Approved half cost of piano purchased from Corner Furniture Store for theatre.

08/01/1950 - Lawn watering allowed only between the hours of 7:00 and 8:00 p.m. Mr. Pinther to be contacted for approval on a proposed well site. In view of the recreation the roller skating provides village young people, it was approved to lower John Delmaire's hall rent to \$5 per night. Kelly Gjovik hired as extra police for two days of Sheep Days at \$5 per day. Bud Johnson to pay Ben Lieberg \$1 for clean-up of refuse he dumped in the streets. Harley Trangsrud paid \$525 for 1950 assessment services. Approved to set up a tree project improvement committee with I.S. Folland.

10/03/1950 - Due to serious water shortage which was declared an emergency, the council authorized an estimate be obtained to drill a test hole to supplement present main well.

10/30/1950 - Test hole #1 to be started as soon as Knute Grahn is available. Verbal permission granted from Joe Duray to drill a test hole at no cost, unless an actual well site was needed. \$100 purchase price for an area 100'x150'.

11/13/1950 - Harley Trangsrud requested

the council endorse a petition to release Art Linder from prison. It was denied as the council felt it was an improper act for them. Roy Paulson and Dale Erickson to receive letters on their driving habits explaining the dangers and penalties.

12/05/1950 - Village election results: Victor Kalinoski, trustee; Tom Jones, justice of peace; Harley Trangsrud, second justice of peace and assessor; John Aas constable. Permission granted to hold a New Year's Eve hospital benefit dance. Herb Reese to level and back fill the hole he excavated at the airport according to original plans and specs; he was also ordered to make a complete statement of all gravel removed from said ground and remit to the village at the rate of eight cents per yard. Melvin Sovde requested an ordinance be adopted to have city issue dray licenses and that no one but a licensed holder act as a drayman.

02/06/1951 - Ralph Wittrich hired as marshal at \$175 per month. He will be provided with instructions informing him of his duty hours from 4:00 p.m. until closing of all public places. He is required to make regular rounds of public places at 45 minute intervals. He is required to check on minors in beer parlors and to check regular routine traffic in the downtown area for two hours, three forenoons each week. No school students are allowed in the pool hall between the hours of 8:00 a.m. and 4:00 p.m. Effective January 1, 1951, John Aas' duties include water superintendent at \$55 per month and fire hall maintenance worker at \$10 per month. Hall rent \$25 for regular outside sponsored dances. Organizations such as the fire department, hospital and ball clubs may rent for \$15.

03/06/1951 - Beer licenses granted to Ben Vigen, Dorothy Kaml, Mary Collins and Paul Pulczynski. Mike Kdrzak's request for a license to operate his own place was refused. Approved John Aas \$65 per month as water superintendent and \$15 per month as hall manager.

04/03/1951 - Due to George Burkel's request for a water supply for a turkey dressing plant which he plans to start operating about September 15, 1951, prices are to be obtained for water extension materials required. The council is to write to the Roseau County Engineer to draw up plans for the street tar-

project and agreement on their share of tarring county roads within the village. Knute Grahn reported test hole #1 dry; Fugleberg property was designated as the next test drilling site. Art Kilen was denied permission to hold auction sale in hall.

05/03/1951 - Ralph Wittrich was instructed to properly display his police badge on the left chest of outer garment. Jewelry shop operator discussed as being generally filthy. Alex Dembiczak was denied permission to have any part of the recreation hall open Sundays. Einar Johnson and Harry Prosser were to be notified that the council has decided to ban parking of old cars or machinery on Main Street for the purpose of selling or parking for a length of time. Building permit granted to Central Lumber Co. Upon explanation by Bob Novotny regarding the probable cost of tarring the eight blocks to be surveyed, he was directed to complete the survey and plans on four blocks. Council representatives to attend county board meeting to procure tarring of county highway from Highway 11 a distance of five blocks. Following complaints by James Stolp and Clara Mortrude regarding highjoke box taxes the council decided taxes would remain at \$50 per year. All dogs without a license would be shot after June 1st.

06/19/1951 - Knute Grahn reported test hole #2 was dry, but that hole #3 proved to be a possible 100 gallon per minute vein and offered to drill main well at \$10 per foot plus cost of screen, pumping and developing at \$6 per hour. Mr. Grahn requested balance of \$120 for test hole #1. Balance of \$460 paid to Benna and James Hasson for well site.

07/03/1951 - Approved ten year water department pumping contract with Ottertail Power Company. Well pump house structure plans and specifications to be ordered, structure to consist of tile material with glass block windows.

07/25/1951 - Tarring petition received and signed by the owners of more than 35% of the real property abutting streets proposed to be improved; hearing scheduled for August 3, 1951.

08/03/1951 - Hearing on proposed tarring. Approved to advertise for bids to black top eight blocks of Fourth Street, Third Street from Central Avenue to Minnesota Avenue, Hill Avenue from the railroad right-of-way to Fourth Street, Minnesota Avenue from Third Street to Fourth Street.

07/07/1951 - Approved \$100 appropriation to I.S. Folland for park tree project and \$150 to local summer recreation program.

10/02/1951 - Approved that the village stand the cost of digging, laying and material of all water hookups up to and including the street valve or curb stop of any new or replacement water service connection. Jay W. Craig Company bid of \$16,185.67 for street improvement project accepted.

10/15/1951 - Bid of Knute accepted for the new water pump and installation of pipe for new well #2.

11/06/1951 - Purchase an additional 70 feet from Benna and James Hasson for new well site for \$325.

12/04/1951 - Letter to be forwarded to Otter Tail Power Company demanding better power service. The power sub-station seems to be the source of much trouble.

01/02/1952 - Newly elected officials: M.W. Peterson, mayor; Walle Gunnarson, trustee; Linn C. Rigstad, constable; Harley Transrud, justice of peace; Chas Anderson, treasurer.

02/05/1952 - Lloyd Lubinski, director of civil defense and ground observer corps, was granted approval to purchase material in the amount of \$74.97 from Central Lumber Company to erect a proper enclosure for the viewers. Effective January 1, 1952, authorized increase in the clerk and treasurer's salaries in the amount of \$30 per year each, to \$150.

03/04/1952 - Ben Vigen and Paul Pulczynski granted beer licenses.

04/01/1952 - Dorothy Kaml granted beer license effective April 2, 1952. Mary Collins application for beer license up for further consideration.

05/15/1952 - Building permit granted to Peter Dembiczak to construct a cement block produce building.

May, 1952 - Purchased property in North Addition from Mrs. Eleanor Bialke for possible alley extension or other purpose for \$100 plus attorney's fees. Building permit granted to Jeff Everson to build a drive-in.

06/03/1952 - Village health officers to inspect Hasson turkey farm and the Johnson Jewelry Store for general nuisance and filthiness. Ralph Wittrich released as marshal because of his drunkenness and disorderly conduct on Monday, June 2, 1952.

07/01/1952 - Council rejected bid from Braun and Helley for water main improvement as it was too high and decided to hire individual day labor including \$6 per hour to dig water main trenches, Arnold Smith

with the dozer at \$9 per hour for backfilling, A. Snare, Axel Lieberg and others to connect, lay and hook up water main; village to supply all necessary materials.

07/16/1952 - Approved contract with Allison-Williams Company for the sale of \$27,000 in municipal bonds, to pay for the proposed water main and street improvements.

09/05/1952 - Water main improvements approved for two blocks on Fourth Street. Assessable cost of this improvement is \$3,600, to be specially assessed against every assessable lot, piece or parcel directly affected. Balance of funds due to Benna and James Hasson for well site property withheld until a clear title is furnished to the village. 02/03/1953 - Village to pay telephone bills for fire hall phone.

- Beer licenses granted to Mary Collins, Dorothy Kaml, Paul Pulczynski, Jr. and Tony Burkel. Dr. L.H. Klefstad presented plans for cleaning up village so that there would be better sanitary conditions. As health officer, he is sending abatement no-

tices to Greenbush Coop Creamery, Einar Johnson, John Sikorski, Ellerd Paulson, Johnson Jewelry; no pennits will be granted to allow persons to raise chickens, turkeys, and livestock within city limits.

04/07/1953 - Anton Novacek was granted four pool table licenses. Due to numerous complaints of property owners, H. Reese & Sons Construction Company is to be sent a copy of ordinance #13, Sections one, three and six by police. If no action taken they are to remove trucks, and heavy machinery from streets and alley before April 20, 1953. 05/05/1953 - Hired Herb Reese to bulldoze, slope and clean river, cost \$75-\$100. Ben Lieberg resigned as garbage collector; Sovde Dray Line to take over.

06/02/1953 - Bemidji Tank and Tower Company of Bemidji to paint water tower, cost \$440; tank to be repaired, if needed, at a cost of \$4 per hour per man. Tower, roof and lettering to be painted aluminum and tank to be painted green.

09/02/1953 - Oral orders given hospital President L. Brekke and Manager Robert Krukowski, that village be informed of any poor relief case hospitalization or medical care for authorization except in acute emergencies.

09/12/53 - Approved Klefstad Addition plat and that village will provide water when three residential units are built.

08/24/1954 - Special meeting held with Civic and Commerce Association. Subject: hearing on regular compulsory garbage and refuse collection and disposal. Vote was taken from the 34 individuals in attendance., who all voted yes to adopt ordinance #28. Proposal to purchase street cleaning equipment; 33 individuals voted yes, Gust Williamson voted no.

06/01/1954 - Approved up to \$200 towards establishment of a Civic Recreation Program.

07/06/1954 - On and off-sale non-intoxicating malt beverage license granted to Jim Stolp to operate tavern in Tony Burkel's building; refunded \$370 to Tony Burkel for license fees, due to ill health.

08/03/1954 - D. Johnson house rent set at \$37.50 per month without alterations, but paint will be furnished when needed. \$480 contributed to the fire department for fire fighting equipment.

08/24/1954 - Robert Evans issued notice to abate nuisance within 90 days - his herd of cows.

09/28/1954 - Michael Seeley appointed peace officer for October for \$225. Ivan Gjovik appointed constable to fill existing vacancy until next regular election. V.A. Temanson resigned as clerk; Marvin Larson appointed.

10/05/1954 - Ben Lieberg granted contract to pick up garbage, \$150 per month. Taxes levied: increased water and light to \$1500; acquired strip of forfeited land on Main Street by paying attorney fees and assessments.

01/104/1955 - 1955 license fees set: dog licenses \$3 for males and spayed females; \$5 for females; pool tables \$10 per table; beer license \$5 off-sale and \$495 on-sale; peddler's except local agricultural \$10; selling merchandise at public auction \$25 per day; dance permit \$1 per dance; transient dry cleaners permit \$10 per day; cigarette \$1 per month; juke box permit \$50. 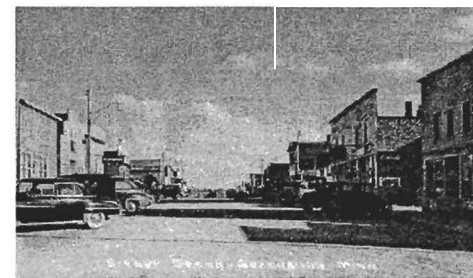

The office of **constable** was a tie vote. According to state law, the council settled the tie by lot and Linn Rigstad was declared elected.

09/03/1957 - Approved ten year contract with Ottetail Power Company for electrical service.

10/01/1957 - Taxes levied: Increased interest and principal to \$3,750.

11/05/1957 - Village curfew hours set for 10:00 p.m. Sunday through Thursday; 11:00 p.m. Friday and Saturday.

12/05/1957 - Don Becken resigned as justice of peace. Election results: M.W. Peterson, mayor; Harry Prosser, trustee; Chas Anderson, treasurer; Stanley Evans, justice of peace; Hector Reese, constable; Lowell Mortrude, assessor.

01/07/1958 - M.W. Peterson stated he intends to resign as mayor due to circumstances which require him to move from village.

02/04/1958 - Dr. A.F. Larson appointed mayor.

02/26/1958 - Approved contract with Ottetail Power Company to provide seven street lights containing the new two tube fluorescent type.

03/06/1958 - Parallel parking to be enforced effective Monday, March 17, 1958. Dorothy's Tavern and Paul's Tavern granted on and off-sale liquor licenses.

03/20/1958 - Following testimony from individuals appearing before the council, request for dance permit by Arnold Smith denied.

03/28/1958 - Mrs. Virginia Montry granted on and off-sale beer license.

05/06/1958 - Approved that on and off-sale taverns be closed at 11:00 p.m. weekdays and 12:00 midnight. Wednesdays and Saturdays. Discussed planning of a golf course and methods for raising funds to finance this project.

06/17/1958 - Approved that a map be made, to include all subdivisions and all water mains for a maximum cost of \$300. Purchased Klefstad and Paulson property for \$1,000 each, to be used for a golf course.

07/01/1958 - Discussed letter from Mr. **Larson** of Detroit Lakes regarding revision

of the original sewer system survey; would cost \$750.

07/14/1958-Surfacing Third Street bid from Herbison Construction Company of Brainerd at 53 cents per square yard, for a total cost of \$2,570 approved.

08/21/1958 - Following hearing, held Sunday, August 18th, with manager of Montry Tavern, Sunday license suspended for ten days.

09/02/1958 - Paul Puiczinski and Milton Olson presented their views against the black list in taverns. Former village hall lot to be filled; decision to be made later.

09/28/1958 - Cost of bituminous improvements of Third Street between State Highway 11 and Minnesota Avenue \$2,570.35. Of this total cost, village paid \$890.35 and \$1,680 specially assessed against benefited property owners.

10/07/1958 - Purchased approximately one-half acre from Dr. Klefstad in Klefstad Second Addition for \$200. The new creamery (cream station) granted permission to enter the L.J. Lorbiecki building from the parking lot for \$1 per month.

10/21/1958 - Approved that Third Street special assessments be payable in equal annual installments for ten years at 5%.

11/03/1958 - R.L. Isherwood granted on and off-sale beer license, \$500 fee. Approved bid from Belmer Thompson for rental of village hall lot, described as Lot 12, north 15 feet of Lot 11, **Block** 13, for an indefinite period, in the amount of \$15 per month.

Following request of Elmer Doran, recreation program committee representative, for financial support, approved contribution of \$300 towards band, which is to have first priority, and recreation program. Greenbush School District, Jeff's Super Service, Arnold Smith and Vernon Fugleberg to be billed for street lights installed.

05/25/1959 - Local beer parlors hours during daylight savings time set as follows, except Sundays: 11:00 p.m. off-sale and 12:00 midnight for on-sale.

06/02/1959 - Contributed \$300 towards maintenance of tree project.

09/01/1959 - Clifford Holm appointed to serve unexpired term as village treasurer due to illness of Charles A. Anderson.

11/03/1959 - Agreement made with Arnold

Smith to erect a motel on the site adjacent to the village property commonly known as the property consisting of 190 feet north of Woodland Industries at a price comparable or less than the price paid for the Klefstad property bordering village property; agreement voided if plan not completed by August 1, 1960.

11/17/1959 - Approved assessment for improvement of Sixth Street by the installation of water mains (commonly referred to as Klefstad Addition). Total cost of improvement project \$1,500, 100% to be assessed against benefited property. Assessment payable in equal installment over ten years at 6%. Tax levy for 1960: bond and interest \$4,200; water \$1,200; street \$2,500; park and recreation \$500; general \$1,600; fire 1 mill; poor \$1,000.

02/06/1960 - Approved sale of north 200 feet of the south 800 feet of Subdivision 8, of Auditors Plat #12 to Woodland Industries, Inc. for \$600 cash and other valuable considerations.

03/12/1960 - Beer licenses granted to Robert Dybedahl. Eugene Lasneski hired full time for \$275 per month to serve as water and street commissioner, and garbage collector to replace Alfred Sather who resigned effective April 1, 1960.

04/05/1960 - To split proceeds of sale of old village hall to Woodland Industries with Civic and Commerce in the amount of \$570.

05/03/1960 - Mr. Temanson discussed securing a site for the new post office; meeting to be held to obtain general public consensus. Contributed \$100 to the Greenbush Baseball Club and \$285 to the C & C as their share of the net proceeds from the sale of the property to Woodland Industries.

08/24/1960 - Bid in the amount of \$5,200 accepted from Fredrickson Inc. of West Fargo, North Dakota, for drilling of a new well. Old well to be cleaned out and determine whether or not it would be feasible to use as an extra water supply.

09/06/1960 - Resolution passed that the vil-

lage regular election held the first Tuesday after the first Monday of December be changed to the regular general election date, the first Tuesday after the first Monday in November, effective November 8, 1960.

10/18/1960 - Conducted a public hearing on the proposed water improvements. Bid of \$3,579.50 awarded to Wagner, Ewald & Corrin to do the digging and laying of the water main extension. Bid of \$2,200 awarded to Snare Plumbing & Heating & Herbert Reese, Sr. to furnish and install deep well pump.

10/25/1960 - Bid granted to Juran and Moody in the amount of \$21,000 for water works improvement bonds over a period not to exceed 15 years, at an interest rate not to exceed 4.5%.

11/09/1960 - Effective October 1, 1960, water minimum rate established for all users, including business and residential, set at \$6 for the first 7,000 gallons; \$40 assessed to each water user for payment of the new well and water mains. All property owners adjacent to the water main from the new well, a southwesterly direction of approximately 2,500 feet (to hydrant) may hook up to main by: 1) payment of usual \$75 hook up fee; and 2) by further payment of \$170 in lieu of usual frontage assessment on property of users. Said \$170 payment may be made in quarterly annual payments of \$10 each; with and in addition to regular quarterly rental for water used, or by a cash payment of \$150.

Second violation will result in parent or guardian picked up and prosecuted accordingly.

03/22/1961 - Approved idea of a swimming program in Lake Bronson for the coming

summer; Hector Reese to be contacted to be the bus driver.

05/01/1961 - Option to be given to Ole Pederson of the easterly 40' of Lot 18 and 19, Block 11, providing that said lots are needed for construction of new post office, with the understanding that Ole Pederson will deed the easterly 50' of the west 100' of Lot 17, Block 11 to the village. Ordinance #28 adopted providing for a traffic violation bureau.

06/20/1961 - Sold property described as the south 400' of Subdivision 8 of the NE 1/4 of SE 1/4 Section 10 to O.H. Nelson for \$700, for the purpose of erecting a substantial building or buildings to be used for business purposes.

07/07/1961 - Granted permit to American Legion Club 88 to operate a bottle club, \$50 permit fee.

08/03/1961 - Bid of \$36 accepted for former Anna Nesteby house and shed. Health officers to inspect Hubert Mattson property due to complaint.

08/30/1961 - Adopted resolution approving plans and specifications for the state improvement of Trunk Highway 11 within the corporate limits of Greenbush.

10/01/1961 - Mr. Aas of the Great Northern Railroad Co. discussed dualizing the agent between Greenbush and Middle River.

12/05/1961 - Hired Boyd Holcomb, CPA, to audit village records. Tax levy that differed from 1960: fire department aid one mill; public library 2.5 mills. Election results: Art Braun, mayor; Harold Nelson, trustee; Gertrude Flaten, treasurer; Hector Reese, constable; Eugene Lasneski and Clifford Heltne, justice of the peace.

01/10/1962 - A joint meeting of the village council and commercial club was held prior to the regular council meeting. Arnold Smith complained that village police are too strict at his pavilion on dance nights i.e. searching cars, etc. Sold tract of property located north of Woodland Industries to Belmer Thompson for \$450.

02/20/1962 - Results of special election in regard to legalizing liquor sales in Roseau County were as follows: wet or no votes 243, dry or yes votes 93.

04/03/1962 - Juke box license lowered to \$30 per year.

04/14/1962 - Adopted Ordinance #29 licensing and regulating the keeping of dogs.

05/01/1962 - Following audit presentation by Phil Kays of Holcomb Auditing, approved transfer of \$1,365.85 from general to garbage fund and \$10,949.09 from general to street fund.
